HIFADHI YA SANAPA**


Kichwa cha habari hapo juu chahusika.

**RE: IMPLIMENTATION OF THE PROVINCIAL COMMISIONER'S RECOMMENDATIONS DURING HIS VISIT  
TO THE VILLAGES NEIGHBOURING SANAPA**

In reference to the above named title

The Coast Regional Commissioner, Hon. Dr. Christine Ishengoma visited the villages neighbouring SANAPA on 28/11/2006. During that visit, he addressed the residents in public gatherings where he ordered that the locals of Uvinje village should not be translocated instead their historical boundaries should be respected by engaging the locals who are conversant with the boundaries. The experts will visit the area and will engage the locals in identifying and establishing the boundaries through survey. Briefings should be given in stages.

The directives of the provincial commissioner has retracted the initial agreement made during the stakeholders meeting held on 09/11/2006, where it was agreed that that the residents of Uvinje be compensated for their properties as they be translocated. The residents of Saadani village should as well be given extra piece of land which they gave out to the park. 1<sup>1</sup>/<sub>2</sub> Km remains to be the agreement made for the Saadani village.

According to this letter you are supposed to take the necessary action immediately after the meetings of the locals in the respective regions.
