The above matter refers.

After revisiting the below three (3) issues that face us:

- (1) Destructive animals on our farms
- (2) Dangerous animals which are a threat to our safety
- (3) The Park maps shows clearly that Uvinje sub-village together with our properties lie inside the Park.

We, putting into consideration the three issues, voluntarily without external coercion and in our sound minds decided to write to TANAPA through Saadani village Executive that our properties be valued.

The following came up:-

On 21/5/2004, we as the property owners, the village leadership, Valuers together with TANAPA representatives went and kicked off the valuation exercise. Surprisingly, there came up a group that brought chaos that caused the entire exercise to be stopped on that day.

Afterwards, we decided to seek alternative means by taking our grievances to the Village Executive and he took the report to the police so that we are given security as the exercise is carried out.

The following day on 22/5/2004, the exercise continued in the company of police from Miono Police Station. But their came a group again like yesterday that caused chaos to the extent of threatening peace. After (unclear words), Saadani Village Chairman, Saadani Village Executive, Location Executive, Officer Commanding Station in unison decided that the entire exercise should stop until a commission from higher authorities is appointed.

Honourable District Commissioner, we express our grievances to you, our welfare is affected, destructive animals continue to destroy our farm produce.

We pray for your help that you give us experts to value our produce.

Cooperate with TANAPA to implement this.

When the exercise is ready we ask for security.
